| Gene Summary | This gene encodes a basic helix-loop-helix transcription factor belonging to the PAS (PER ARNT SIM) superfamily. The PAS proteins play important roles in adaptation to low atmospheric and cellular oxygen levels exposure to certain environmental pollutants and diurnal oscillations in light and temperature. This protein forms a transcriptionally active heterodimer with the circadian CLOCK protein the structurally related MOP4 and hypoxia-inducible factors such as HIF1alpha. Consistent with its role as a biologically relevant partner of circadian and hypoxia factors this protein is coexpressed in regions of the brain such as the thalamus hypothalamus and amygdala. Alternatively spliced transcript variants encoding different isoforms have been described for this gene. |




Amplification Plot

Amplification of cDNA generated from 25 ng of universal reference RNA




Melt Peak

| Assay Design | Exonic: Primers sit within the same exon in the mRNA transcript and can potentially co-amplify genomic DNA. If performing gene expression analysis, it is suggested that the samples be treated with a DNase to eliminate potential unwanted signal from contaminating genomic DNA. |
| | Exon-exon junction: One primer sits on an exon-exon junction in mRNA. When performing gene expression analysis, this design approach will prevent unwanted signal from contaminating genomic DNA. |
| | Intron-spanning: Primers sit within different exons while spanning a large intron in the mRNA (intron is greater than 750bp). When performing gene expression analysis, this design approach should limit potential unwanted signal from contaminating genomic DNA. |
| | Small intron-spanning: Primers sit within different exons with a short intron in between (intron is smaller than 750bp). Small introns may not prevent unwanted signal from contaminating genomic DNA. |
| Efficiency | Assay efficiency was determined using a seven-point standard curve from 20 copies to 20 million copies. While an efficiency of 100% represents a perfect doubling of template at every cycle and is ideal, typical ranges of good assay efficiency are between 90-110%. For difficult targets, assay efficiency outside of this range are accepted and reported accordingly. |
| R ² | The R ² represents the linearity of the standard curve and how well the standard curve data points fit the linear regression line. Acceptable values are >0.98. |



| cDNA Cq | Cq value obtained from 25ng of cDNA transcribed from universal RNA when performing wet-lab validation of the assay. |

| cDNA Tm | Melting temperature of the amplicon when running a melt curve analysis. |
| gDNA Cq | Cq value obtained when running the assay with 2.5ng of genomic DNA. This is more than a moderate level of genomic DNA contamination. Intron-spanning and exon-exon junction assay designs can minimize or eliminate genomic DNA detection. Note: Genomic DNA contamination is often present at variable levels. If concerned |

| Specificity | This value is the percent of specific amplicon reads as measured by next generation sequencing (NGS).
