Alternatively spliced transcript variants have been observed for this gene. Single nucleotide polymorphisms in this gene have been associated with both nicotine and alcohol dependence. |




### **Amplification Plot**

Amplification of cDNA generated from 25 ng of universal reference RNA




#### **Melt Peak**
