The olfactory receptor gene family is the largest in the genome. The nomenclature assigned to the olfactory receptor genes and proteins for this organism is independent of other organisms. |




#### **Amplification Plot**

Amplification of cDNA generated from 25 ng of universal reference RNA




#### Melt Peak
