The alpha subunits of these hormones are identical however their beta chains are unique and confer biological specificity. Mutations in this gene result in congenital hypothyroidism. |




#### **Amplification Plot**

Amplification of cDNA generated from 25 ng of universal reference RNA




#### **Melt Peak**
