

## Myo1c, Rat


#### **Amplification Plot**

Amplification of cDNA generated from 25 ng of universal reference RNA




#### **Melt Peak**

Chromosome Location	This is the chromosomal location of the amplicon context sequence within the genome.
Assay Design	Exonic: Primers sit within the same exon in the mRNA transcript and can potentially co-amplify genomic DNA. If performing gene expression analysis, it is suggested that the samples be treated with a DNase to eliminate potential unwanted signal from contaminating genomic DNA.
	Exon-exon junction: One primer sits on an exon-exon junction in mRNA. When performing gene expression analysis, this design approach will prevent unwanted signal from contaminating genomic DNA.
	Intron-spanning: Primers sit within different exons while spanning a large intron in the mRNA (intron is greater than 750bp). When performing gene expression analysis, this design approach should limit potential unwanted signal from contaminating genomic DNA.
	Small intron-spanning: Primers sit within different exons with a short intron in between (intron is smaller than 750bp). Small introns may not prevent unwanted signal from contaminating genomic DNA.
Efficiency	Assay efficiency was determined using a seven-point standard curve from 20 copies to 20 million copies. While an efficiency of 100% represents a perfect doubling of template at every cycle and is ideal, typical ranges of good assay efficiency are between 90-110%. For difficult targets, assay efficiency outside of this range are accepted and reported accordingly.
R <sup>2</sup>	The R <sup>2</sup> represents the linearity of the standard curve and how well the standard curve data points fit the linear regression line. Acceptable values are >0.98.



cDNA Cq	Cq value obtained from 25ng of cDNA transcribed from universal RNA when performing wet-lab validation of the assay.
	Note: Not all genes will be expressed at a detectable level in the universal RNA sample.
cDNA Tm	Melting temperature of the amplicon when running a melt curve analysis.
gDNA Cq	Cq value obtained when running the assay with 2.5ng of genomic DNA. This is more than a moderate level of genomic DNA contamination. Intron-spanning and exon-exon junction assay designs can minimize or eliminate genomic DNA detection.  Note: Genomic DNA contamination is often present at variable levels. Specificity	This value is the percent of specific amplicon reads as measured by next generation sequencing (NGS). While 100% specificity is desirable, small decreases in specificity (<1%) can be due to NGS read errors. More significant reductions are likely due to co-amplification of homologous regions.  Note: Since gene expression can be cell type and condition specific, the exact level
	and impact of co-amplification in a given sample is impossible to predict. If co-amplification is detected, it should be taken into consideration and reported when analyzing gene expression results.
