

Tsc22d3, Rat


Amplification Plot

Amplification of cDNA generated from 25 ng of universal reference RNA




Melt Peak

| | Intron-spanning: Primers sit within different exons while spanning a large intron in the mRNA (intron is greater than 750bp). When performing gene expression analysis, this design approach should limit potential unwanted signal from contaminating genomic DNA. |

| Efficiency | Assay efficiency was determined using a seven-point standard curve from 20 copies to 20 million copies.
